**NORTH REGION/TAYSIDE REGION JUNIOR  
FOOTBALL ASSOCIATION**

**CONSTITUTION**

1. The Association shall be called 'North Region/Tayside Region Junior Football Association'.
2. The object of the Association is to promote the game of Association Football.
3. The Association shall have control in all matters connected with football played under its jurisdiction, and shall have power to deal, by way of expulsion, suspension, or fine, or otherwise as may be thought fit, with any Club in Membership of the Association, its Officials, Representatives, Members, and Players who, in the opinion of the Association or of the Committee or of a Sub-Committee aforementioned, are guilty of misconduct, or of a breach of these Rules, or in any way acting prejudicial to the interests of the Association.
4. Each Member, its Officials, Representatives, Members and Players shall be bound by the Constitution and Rules, and by the decisions of the Association and of the Committee and Sub-Committee, and such decisions, subject to the right of appeal after mentioned, shall be final and binding on the Association, its Members, and all others mentioned, and shall not be subject of review in or by a Court of Law. No appeal shall lie against any decision to the Association, but any Club, Official, Representative, Member, or Player dissatisfied with a decision has the right to appeal to the Appeal Committee appointed by the Scottish Junior Football Association under, and in terms of, that Association's Rules.

## MEMBERSHIP

5. All Clubs in membership of the North Region and Tayside Region of the Scottish Junior Football Association shall be eligible for membership subject to approval of the Committee.
6. Application for membership by Clubs shall be made in writing to the Secretary of the Association and shall be signed by the President and the Secretary of the Club seeking admission not later than the first Wednesday in June each year.
7. Each Club in membership of the Association shall keep proper books showing its financial and other transactions.
8. The Annual Subscription for each Member shall be **£15.00 (fifteen pounds)** [inclusive of Rule Books], and shall be payable at. or before the Annual General Meeting in each year. Any Member whose subscription is not paid by the Annual General Meeting in each year shall cease to be a Member of the Association.
- 8a. Any Club failing to be represented at the Annual General Meeting shall be fined the sum of **£100.00 (one hundred pounds)**.
9. Each Club shall forward, by the last day of June, to the Secretary of the Association, for registration by him, a statement having its name, its ground, the name and address of its Secretary, and its distinguishing colours.
10. Any Member resigning, or being expelled, or becoming defunct, or otherwise ceasing to be a Member, shall have no right or interest in the property or assets of the Association.
11. A Club, Club Official, Member, or Player suspended by this Association or by an Association affiliated to, or permitted by, the Scottish Junior Football Association, shall not be eligible to take part in any football, football management, or play for any Club in this Association.



## **MEETINGS**

12. The Annual General Meeting will be held on the first available date as agreed by the Management Committee, at which meeting and at any Special General Meeting, each Club shall be entitled to send a Representative. Any Club whose subscription remains unpaid shall not, during the non-payment, be entitled to have a Representative at the Annual General Meeting or at any other meeting of the Association or of its Committee. The Annual and all General Meetings shall be held at a suitable venue, unless the Committee otherwise determine, and shall be called on seven days' notice. Twenty-five per cent Representatives present at such General Meeting shall constitute a quorum. The Chairman shall have a deliberate as well as a casting vote. In the absence of the President and Vice-President the Meeting shall appoint a Chairman.
13. A Representative to the Annual or Special General Meeting shall be appointed by each Club entitled to send a Representative, and a letter containing such appointment, signed by a recognised Official of the Club, shall be lodged with the Secretary at, or prior to, the Meeting.

## **OFFICE BEARERS**

14. At the Annual General Meeting, Office-Bearers shall be appointed for the ensuing season, each of whom may be granted an honorarium. These Office-Bearers shall consist of President, Vice-President, who must be members of a Club in Membership of the Association, General Secretary, Discipline Secretary, Assistant Secretary, who must be neutral, and Treasurer, who may be neutral.
15. The affairs of the Association shall be conducted by a Management Committee consisting of President, Vice-President, General Secretary, Discipline Secretary, Assistant Secretary, who must be neutral, and Treasurer, and three members from each of the North Region and

Tayside Region of the Scottish Junior Football Association. Such elected Representatives shall be elected at the Annual General Meeting and must be members or officials of a Club in the Region they represent. The Management Committee shall have full powers vested in them.

16. All meetings of the Management Committee shall be held at a suitable venue determined by the Management Committee. One third of the Members shall form a quorum. Members shall retire when matters affecting their Club are under discussion.
17. The Management Committee shall have power to settle financial disputes between Clubs in Membership, and to adjudicate upon financial claims made against Clubs, and where any Club is found liable to pay a sum to any other Club or Official, the Officials, Members, and Registered Players thereof shall be liable to fulfil the order of the Committee, and the Committee shall be entitled to make a pro-rata division thereof among such Officials, Members, and Players. Any Official, Member for being notified thereon by the Secretary shall stand suspended until payment, and any Officials or Members so suspended shall not be eligible to play for any Club in Membership of the Association while so suspended, provided always that this Rule shall not apply to any dispute which fails to be determined by the Scottish Football Association Ltd.
18. The Management Committee shall have power to fill vacancies in the Office-Bearers and Management Committee on a *pro tem* basis as the need arises.
19. Any Member completing five years on the Management Committee with 75% attendance shall be created an Honorary Life Member. He shall receive a token and Life Member's Card, entitling him to admission to all grounds of Clubs in membership of the Association.

20. The Chairman shall have a deliberate and casting vote. In the absence of the President and Vice-President the Committee shall appoint a Chairman.
21. Second class railway fares and any other necessary expenses of Members of the Management Committee shall be defrayed by the Association when such Members are engaged on business of the Association.

### **TRUSTEES AND FUNDS**

22. The President, Vice-President, General Secretary, Discipline Secretary, Assistant Secretary and Treasurer for the time being shall be trustees *ex-officio* of the Association. They shall hold all the property of the Association and all investments shall be in their names and their successors in office for behoof of the Association. All accounts and payments shall be submitted to the Committee and the Treasurer shall submit a financial statement and vouchers to each meeting, which statement shall be included in the minutes. Accounts and payments shall, as far as possible, be paid by cheque. The Treasurer's accounts for each year shall be audited by two Representatives appointed at the Annual General meeting, one of whom shall not be eligible for re-election. No Official or Member of the Committee shall be eligible to hold office as Auditor.
23. The funds of the Association shall be lodged, in the name of the Association, in a bank appointed by the Committee, and all cheques drawn thereon shall be signed by any two of the following: President, Vice-President, General Secretary, Treasurer, Discipline Secretary or Assistant Secretary.
24. The Association shall effect a Fidelity Guarantee Insurance guaranteeing the intromissions of the Treasurer not exceeding £1000.00.

### **CUP COMPETITION**

- 25.** The Association shall conduct annually a competition among its Members for a cup. The competition shall be open to all the Clubs in the Association, subject to the approval of the Committee.
- 26.** Each year the names of the Clubs entered for the competition shall be placed by the Committee in two lots and shall be drawn regionally for the first two rounds. The first named Club shall have ground advantage. The third round shall be seeded and the names of the competing Clubs shall be placed in two lots, one from each Region, North and Tayside. The first four teams drawn from the North lot shall be at home to the first four drawn from the Tayside lot and the second four drawn from the Tayside lot shall be at home to the second four drawn from the North lot. No Club shall have more than one bye unless under unavoidable circumstances. All games shall be completed at the first attempt and in the event of equality at the end of ninety minutes penalty kicks shall be taken to decide the tie. The penalty kicks shall be taken according to the FIFA Penalty Kick Rule. In the fourth round all the names of the competing Clubs shall be put in one lot and the matches shall be played as drawn. The semi-final and final ties shall be played at grounds decided by the Committee who shall be responsible for all arrangements. The Clubs competing in the semi-final and final ties shall be bound to play on the ground and date allocated for such tie. None of these Clubs shall be entitled to scratch and Clubs undertake, under penalty of paying the whole expense incurred by the Association and the opposing Club, to play the semi-final and final tie.
- 26a.** In the event of a tie being cancelled on 2 occasions the game shall be moved to its opponent's ground or a venue suitable by the Management Committee if more than 50% of games on the due date are cancelled.

27. Any Club scratching from the North Tayside Region Cup prior to the semi-final and final ties shall be fined in the sum of **£100.00 (one hundred pounds)** and **suspended from the competition the following season**, and the fine shall go to their opponents as compensation for loss of game, plus any additional sum the Committee may determine.
28. A Club on whose ground the final tie, or tie in which it is not a competitor, is played, shall receive 10% of the net gate drawings, with a minimum of **£20.00 (twenty pounds)** [including groundsman's fee] for the use of the ground, pavilion and dressing room accommodation. Any Club whose ground is being utilised for the final tie will **NOT** be allowed to play on that day and no games will take place within a 20 mile radius of the final tie.
29. A player who has played for a Club in a cup competition of this Association in any season cannot play in the same season for another Club in this competition.
30. Players must appear in registered colours in cup-ties, otherwise their Club shall be liable to be fined or disqualified, but it shall not be grounds for a replay. When the Clubs have similar, or nearly similar, colours, the **Away Club** must change. In semi-final or final ties where Clubs colours are similar, or nearly similar, both teams must change. In all games the goalkeeper must wear a jersey distinctive in colour from that of his own team and of his opponents.
- 30a. In all games the Secretary, or person in charge of the team, shall hand to the Referee, prior to the commencement of the game, two lists of the proper names (First Names in full) of their respective teams including **SEVEN** substitutes. Players must be numbered and this should correspond with the player's full name on the team list. The Referee shall compare and sign all lists and shall hand one copy to the opposing Club and send one copy to the Association

Secretary, with the score and duly signed, within **TWO DAYS** thereafter (Sundays excluded). The Association Secretary shall keep a register of all players taking part. The Registration Lines shall be open for inspection at a fee of **£2.00 (two pounds)**. Any person violating this rule will be dealt with by the Management Committee.

31. Admission shall be as, from time to time, those fixed by the S.J.F.A. for the Scottish Junior Cup. Up to, and including, the fourth round. The Home Club shall be responsible for the Referee's and Assistant Referee's (if applicable) fees and expenses and shall retain the gate.

In Semi-Final ties the Region shall receive 25% of the nett Gate Drawings and the balance divided equally amongst participating Clubs after deduction of Officials Fees and Expenses. The final tie shall be conducted by the Association.

32. The Association shall present to the winners of the Final Tie the North Tayside Region Cup and to the winners and runners-up 25 prizes each. The winner of the trophy shall grant a guarantee for the safe custody and return of the trophy (suitably engraved) by the first day of May each year.

33. Protests shall be heard and decided by the Committee. A Club protesting must lodge the protest, specifying the date and nature of the objection, with the Secretary of the Association and accompany it with a deposit fee of **£50.00 (fifty pounds)**, and send a copy of the protest to the opponent's Secretary, both of which must be sent by registered post and bear a post date not later than the third day following that on which the match is played, Sundays and Public Holidays excluded. Protests once lodged cannot be withdrawn but must be proceeded with by the protesting Club. The Committee may inflict upon a Club which it considers to be at fault such penalty as

it may determine, and, in the event of a Club playing a player against whom an objection of ineligibility has been sustained, the Committee may, in addition to any penalty, award the tie to its opponents. If the protest is sustained the protest fee shall be returned after the days of appeal have expired without appeal, but if it is dismissed it shall be retained by the Association. If a protest be considered trivial or groundless, or be dismissed unanimously, the Committee may order the protesting Club to pay the expenses, in whole or in part, incurred in connection with the protest by both or either of the Association and the Club protested against, or inflict a fine or both. If an appeal be taken against the decision of the Committee, the deposit fee shall be retained if the decision on appeal be against the protesting Club. Should any Club in connection with a protested match have a Member on the Committee that Member shall not be eligible to sit during the hearing and any decision, but shall retire from the meeting. If the hearing be not finished at the first sitting, both sides shall hand all documentary evidence and names of witnesses to the Secretary. No evidence other than that handed in shall be taken at the second or subsequent meetings.

34. The Referees' fees all rounds prior to Quarter-Final  
Referee £65  
Assistants £32.50  
Quarter-Final through to Final

35. In the second, third and fourth rounds of the competition the Clubs shall only be responsible for the match fee of the Referee and Assistant Referees (where applicable). Travelling expenses will be borne by the Association. In the final tie all expenses will be borne by the Association. In the second and subsequent rounds of the competition Club travel will be recompensed at a rate at the discretion of the Management Committee per mile, one way. In the

final tie the Association will guarantee **£4.00 (four pounds)** per mile one way for travel.

### **GENERAL**

36. Members of the Committee of the Scottish Junior Football Association shall, on production of their membership card, be admitted to the grounds of all Clubs in this Association.
37. Any matter arising between, or affecting the Association and/or others under its jurisdiction, not specially provided for in these Rules, shall, if provided for by the Rules and Cup Competition Rules of the Scottish Junior Football Association and, so far as they affect that Association, the Articles of Association of the Scottish Football Association Ltd be regulated by such Rules and Articles, to which extent the said Rules and Articles, are incorporated in, and held to be part of, these Rules, but if such matter be not so provided for it shall be submitted to, and determined by, the Committee.

### **DISSOLUTION OF ASSOCIATION**

38. Notice of Motion to the effect that the Association be dissolved and its affairs wound up may be given at any time by two Members to the Secretary. Within ten days of receipt of such Notice of Motion - if same be in the sole opinion of the Committee in order - the Secretary shall call a Special General Meeting of Association, to be held at such place and time (not less than seven days or more than ten days from the date of his calling the meeting) as the Committee may determine for the purpose of considering the motion, which shall be incorporated in the circular calling the meeting. Should the motion be passed by a majority of the Representatives present at the voting at such meeting, the Association shall be dissolved by, and as at the date of, the passing of the motion. On said motion being passed, the meeting shall appoint some person or persons to wind up the affairs of the



Association, and he or they shall have sole control of the winding-up. Its assets and books, papers and documents shall be delivered or transferred forthwith by the Trustees of the Association, or others holding the same, to such person or persons; and he or they shall sell, or as directed by the Members, or a majority of them, otherwise dispose of the assets and wind up the affairs of the Association. On completion of the winding-up, and after deducting the expenses thereof, the surplus assets of the Association (if any) shall be divided equally between its Members, or otherwise be disposed of as the members, or a majority of them, may direct. After a motion to dissolve and wind up has been passed, no Member, whether opposed to or not thereto, shall carry on the Association, or use its name, or require delivery or transference of its assets or its books, papers or documents, or have a greater right or interest in its assets or its affairs than any other Member.

### **ALTERATION OF RULES**

- 38.** These Rules shall not be amended to or added to, except at the Annual General Meeting, or Special General Meeting called, on the instruction of the Committee, for the purpose, or as aforementioned. The Committee and Members shall have power to propose amendments or additions. Notice of amendments or additions proposed for consideration at the Annual General Meeting must be intimated to the Secretary at least fourteen days prior thereto. Notice of amendments or additions proposed for consideration at a Special General Meeting must be sent to the Secretary, and submitted by him to the Committee, who may or may not instruct a Special General Meeting to be called. The decision of the Committee shall be final. If the Committee do not instruct a Special General Meeting to be specially called for the consideration of the proposals, the proposals, unless otherwise withdrawn, shall be considered at the next Annual or Special General Meeting, whichever be the first.
